Location of the Activities:

If in the content of this Agreement a word is used with a capital letter, the word shall be given the meaning according to §1 of the Regulations, which is an integral part of this Agreement.

§ 2

- 1. The Guardian declares that he/she is the legal guardian and the person authorized to make decisions on behalf of the Player, has custody of the Player, and his/her right has not been limited or excluded in any way.
- 2. The Guardian agrees to the Player's participation in the Activities and Competitions and declares, that he/she is not aware of any contraindications to participation in the Activities and Competitions.
- 3. The Organizer agrees to provide the organization of the Activities under the terms and conditions specified in this Agreement and in the Regulations for the person designated by the Guardian, i.e. the Player, for remuneration, in the form of Fees, as detailed in the Regulations.

§ 3

- 1. The Activities shall take place periodically, according to the Schedule set by the Organizer. Depending on the Age group, the Activities shall take place from one to four times a week.
- 2. The Activities shall take place at the Sports Facility or any other suitable location specified by the Organizer (except that it may be either an open area, a regular facility or covered or partially covered facility), in accordance with the Schedule.

- 1. The Guardian undertakes to pay fees in a timely manner, in the amounts indicated in the Agreement, Price List and Regulations or as amended or introduced in the manner indicated in § 4 of the Regulations or by amending the Regulations in the manner specified in § 15 of the Regulations.
- 2. All payments, related to the Agreement, will be made by the Guardian in the form of a bank transfer, only to the account indicated by the Organizer. The title of the transfer should include: the name and surname of the Player, and the month and year for which the Fee is paid.
- 3. The Organizer's bank account numbers for making payments are available on the Organizer's Website.
- 4. The Organizer has the right to change the bank account number at any time. In the event of a change in bank account numbers, the Organizer will inform the Guardian by e-mail with one week's notice.

§ 5

- 1. The Agreement is concluded for an indefinite period of time.
- 2. Each party has the right to terminate the Agreement with one month's prior notice, effective at the end of the calendar month. During the notice period, the Player has the right to participate in activities in accordance with the Schedule.
- 3. The termination of the Agreement requires written form. Termination of the Agreement by the Guardian may be made to the Organizer's e-mail address (kontakt@akademiaferajna.pl).

§ 6

- 1. The Agreement has been drawn up in two counterparts, one for each Party.
- 2. The Agreement enters into force on the date of its signature by the Parties.
- 3. The Guardian declares that he/she has read the Regulations, Price List, Schedule, which are an integral part of the Agreement.
- 4. The Regulations and its subsequent versions can be consulted at the Organizer's office and on the Organizer's Website.
